Terms & Conditions

In order for you to be considered as an volunteer for Community Action Nepal, you must read the following terms and conditions and sign the declaration below.

- You must be 18 or over on the date of departure.
- You must not suffer from alcohol or drug dependency.
- As an organisational requirement, you must inform **Community Action Nepal** of any past or current criminal convictions. Details provided will be treated in the strictest confidence, and accessed only by official personnel. Please include these details in a separate envelope marked **Private and Confidential**. Trustees can request checks with the Criminal Records Bureau. These would be confidential.
- Should you, your friends or family wish to return to the site of a **CAN** project once your placement has been completed, you must inform **CAN** at the earliest opportunity. You must make **CAN UK** fully aware of such contact intentions at all times.
- All information disclosed on the medical form must be a true and fair representation of your state of health at this current time. If your state of health should change prior to your placement, please inform **CAN** immediately.
- **CAN** will be responsible for the costs of your accommodation, food and transport once at the project site. You must finance all transportation to and from Nepal, onward flights, portering, accommodation and food when not at the project.
- You must take full responsibility for yourself, and act in a way that is sensitive to the needs of staff, the reputation of **CAN**, the local population and the environment.
- Your passport must run for at least six months after the date of your return.
- You must have full travel and personal insurance cover. Your policy must include emergency repatriation and helicopter rescue. **CAN's** UK office can provide assistance in finding a suitable policy. You must have insurance cover for all eventualities.
- **CAN** does not accept responsibility for any accidents to your person, your property or a third person.

Declaration

Community Action Nepal cannot be held responsible for loss or damage to personal property, nor the unlikely event of injury or death. You must, therefore, take full responsibility for your own safety, well being and possessions.
